For your first stop, visit the Railroaders Memorial Museum. The museum, located in the Pennsylvania Railroad's former Master Mechanic's Building, seeks to preserve the stories and contributions of Central Pennsylvanians who left an imprint on their communities, industry, and nation. Museum displays include a rich array of artifacts, immersive environments, and life size dioramas of railroad workers performing various tasks typical of the Altoona Shops.

Next, travel the short distance to the famed Horseshoe Curve. Completed in 1854 by the Pennsylvania Railroad, the Horseshoe Curve was created to lessen the grade to the summit of the Allegheny Mountains. The Horseshoe Curve was designated a National Historic

Landmark in 1966 and became a National Historic Civil Engineering Landmark in 2004. Ride the funicular* or walk the 194 steps — to the train tracks for a front row seat to one of the eight engineering marvels of the world, the Horseshoe Curve! **The funicular is expected to reopen prior to this Ramble, but there is a possibility it may not be available August 21, 2022. In the event the funicular is not operational, visitors must climb the stairs to access trackside viewing platform.*

For lunch, visit the U.S. Hotel in nearby Hollidaysburg for an included buffet lunch. Experience the 19th century charm of this historic landmark along the western end of the Pennsylvania Canal and the Allegheny Portage Railroad. The final stop is the Everett Railroad for a 2.5-hour round trip Ice Cream Special train between Hollidaysburg and Roaring Springs. Your excursion is scheduled on a steam locomotive* with reserved seating. The train will be enclosed with windows that can be opened, but no air conditioning is available onboard. Your ticket includes a scoop of ice cream, which will be served at the depot in Roaring Spring. Additional refreshments will be available for purchase during the 1-hour layover. **Equipment changes may occur, including the switch from a steam locomotive to a diesel-powered locomotive. Equipment changes may occur without advanced notification and/or compensation.*

Upon returning to the station, prepare to depart for Central PA. A fast-food meal stop (at own expense) will be made en route.

Tour Activity Level: 2 - *This tour requires average physical activity. You should be in good health, able to climb stairs, and walk reasonable distances possibly over uneven ground and cobblestoned streets. Please note: The equipment used by the Everett Railroad is historic in nature and, as such, is not handicap accessible.*

This Ramble is subject to cancellation due to insufficient and/or late registration. Payment: Register by **June 17, 2022!** Full payment is due to AAA Central Penn with completed registration form to confirm the reservation.

Cancellation/Penalties: A \$25 per person cancellation fee will be charged by Discoveries in addition to any other supplier's fees. After **June 17, 2022**, no refunds.
